COMMUNICATION TO THE SHAREHOLDERS

Dear Shareholders,

The Company is pleased to inform its shareholders that the Board of Directors of Aegis Logistics Limited ("the Company") at their meeting held on Thursday, June 19, 2025 declared the payment of Interim Dividend of Rs. 2/- per Equity share i.e. 200% on face value of Re. 1/- each for the financial year 2025-26. The said Interim Dividend will be payable to those members whose names appear in the Register of Members/ list of Beneficial Owners as provided by the Depositories i.e. National Securities Depository Limited (NSDL) and Central Depository Services (India) Ltd (CDSL) as on Wednesday, June 25, 2025 (Record date fixed for Interim dividend payment).

As you may be aware that as per the Income Tax Act, 1961 ("the Act"), dividends paid or distributed by a Company after April 1, 2020 shall be taxable in the hands of the shareholders. The Company shall therefore be required to deduct tax at source ("TDS") at the time of making the payment of the said Interim Dividend.

The TDS rate may vary depending on the residential status of the shareholder and the documents submitted to the Company in accordance with the provisions of the Act. The TDS for various categories of shareholders along with required documents are provided in Table 1 and 2 below:

It has been observed and intimated by the registered shareholders as on the record date such as Broking firms/custodians/ depository participants informing dividend has been credited to their bank accounts and TDS credit was given to them when shares belong to their clients and requested Company to transfer TDS benefit to their clients. In this case, please note that if the dividend income is assessable to tax in the hands of a person other than the registered shareholder as on the record date, the registered shareholder is required to update a signed declaration under rule 37BA(2) of the Income-tax Rules, 1962 containing the name, address, permanent account number of the person to whom TDS credit is to be given and reasons for giving credit to such person by visiting the link https://web.in.mpms.mufg.com/formsreg/submission-of-form-15g-15h.html on or before June 25, 2025 and avoid the situation of transfer of TDS benefit to their clients at a later date.

The TDS certificate will be sent at the shareholders registered email ID in due course, post payment of the said Dividend. Further, shareholders will also be able to see the credit of TDS in Form 26AS, which can be downloaded from their e-filing account at https://incometaxindiaefiling.gov.in.

It may be further noted that in case the tax on dividend is deducted at a higher rate in absence of receipt of the details/documents, there would still be an option available with the Member to file the return of income and claim an appropriate refund, if eligible. No claim shall lie against the Company for such taxes deducted.

No communication/documents on the tax determination / deduction shall be considered post 11:59 PM (IST) of June 25, 2025.
